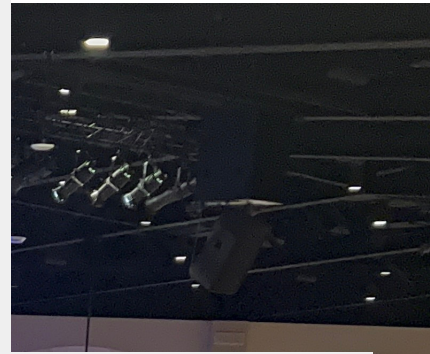

Year in Review

Highlights & Accomplishments

The 2022-2023 school year was filled with a host of educational opportunities as well as special events and athletics competitions. Here are just some highlights from the past year.

- PA Universal Free Breakfast Program offered free breakfast to ALL students beginning in October 2022.
- Renovations to the Cocalico High School technology education department, family and consumer sciences department, auditorium, front entrance, and IT departments were completed.
- All elementary teachers began using the iReady math textbook.
- Student participation in after school tutoring at the secondary level increased. The benefit of district-sponsored transportation allowed more students to attend.
- Summer programming in 2023 continued to focus on addressing learning loss during the summer months. Transportation, paid with grant funds, was provided.
- Middle School STEM courses were expanded to all three grade levels.
- All course curriculum documents were revised and reviewed by K-12 faculty.
- A new early learning opportunity, Raising a Thinking Child, was held.
- Nearly 300 students and staff were recognized for their academic, fine arts, or athletic achievements. These Eagle Excellence Recognitions were held at monthly School Board meetings.
- The district was named a 2022-2023 Imagine Learning District of Distinction for the exceptional use of the Edgenuity online program for Cocalico Connections.
- New senior events were held - a Senior Commitment ceremony, with over 40 students in attendance; a Senior Building Parade, with over 100 seniors participating; and Senior Sunrise/Sunset celebrations, with nearly 50 participants.



Assessment Data



The following pages highlight district performance in various indicators of student achievement. Overall, Cocalico students fared extremely well in academic performance measures. Thanks to the district's focus on addressing barriers to learning, many assessment results returned to pre-pandemic numbers.

The Pennsylvania Department of Education (PDE) made a few changes to the way they interpret data for the Future Ready Index, a public record of school progress measures related to school and student success. These changes affect the following reports:

- Keystone Exams
 - Students, who were exempted from the exam during the pandemic and thus earlier reported as proficient, are not included.
 - Thus, the percentage of advanced/proficient students has appeared to decrease.
- Attendance rates (reported one year behind, data for the 2021-2022 school year)
 - PDE has changed their description for what they consider “chronically absent” to now include students who are absent regardless of whether absences are excused or unexcused.
 - Thus, the following are now coded as absences for purposes of chronic absenteeism and regular attendance measures:
 - Out-of-school suspensions
 - Approved family-sponsored educational trips
 - College visits NOT connected to curriculum
 - Bereavement
 - Absence with/without a doctor's note

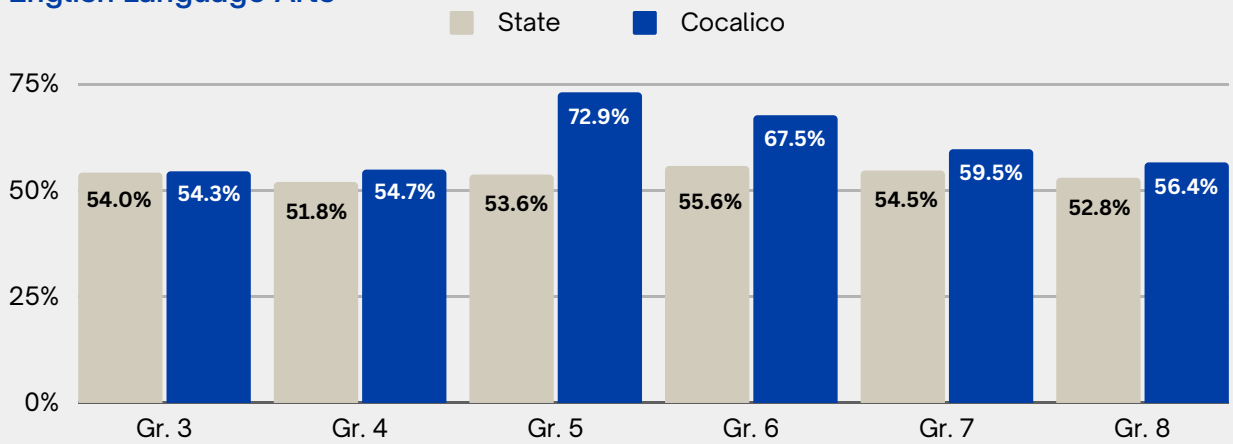
PSSA Exams



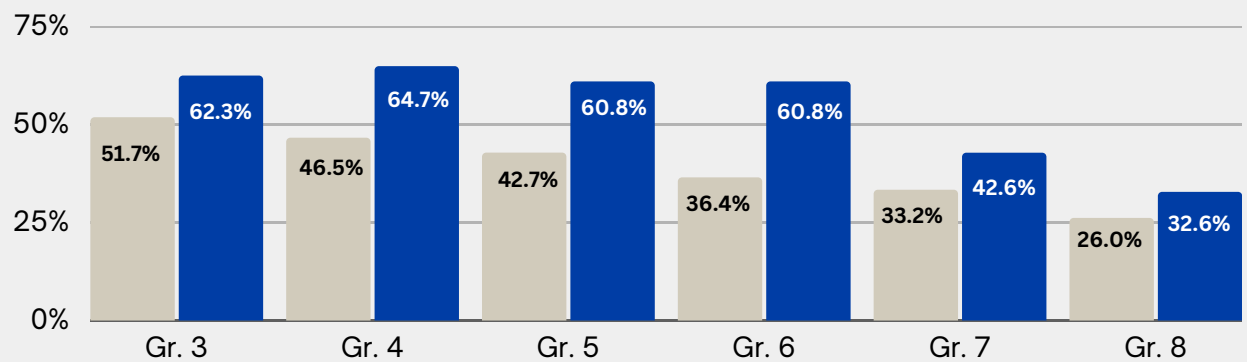
The annual Pennsylvania System of School Assessment (PSSA) is a standards-based, criterion-referenced assessment aimed at measuring a student's attainment of the academic standards while also determining the degree to which school programs enable students to attain proficiency of the standards. Every public school student in Pennsylvania in Grades 3-8 is assessed in ELA and Math. Students in Grades 4 and 8 are also assessed in Science.

The following charts depict the percentage of students who were advanced or proficient on the 2023 Spring PSSA Exams. In all grade levels and all subject areas, Cocalico students outperformed their peers from across the state.

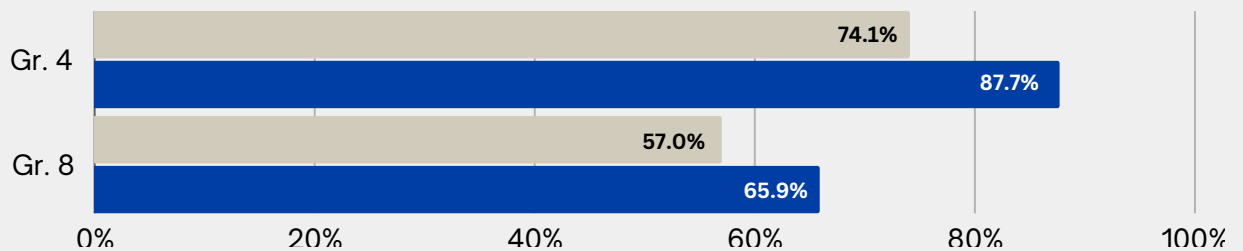
English Language Arts

Science

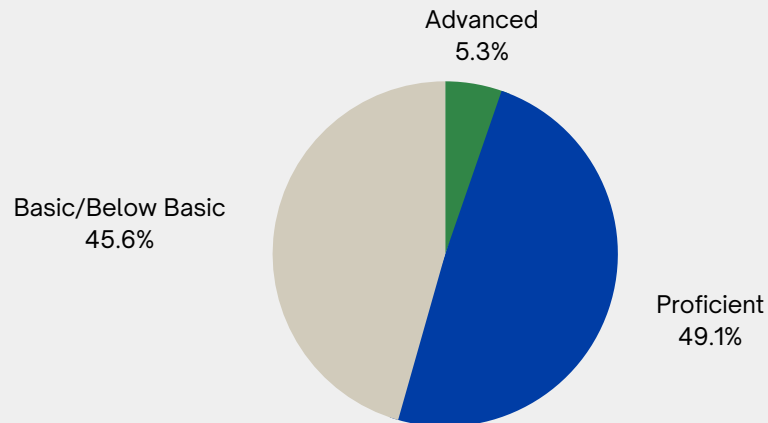


Keystone Exams

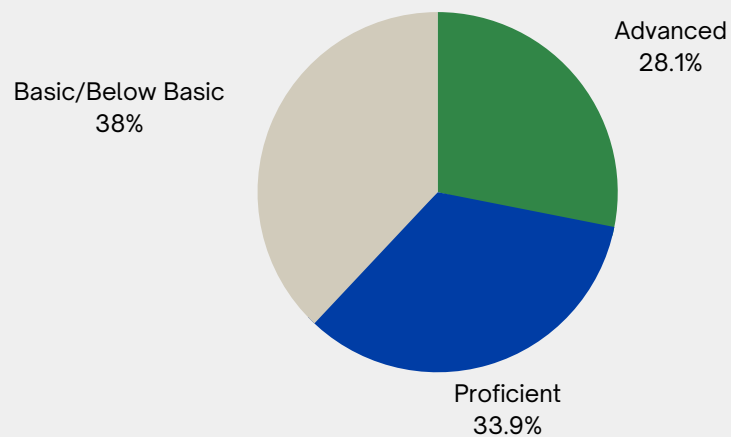


Keystone Exams are end-of-course, PDE-required tests designed to assess performance in the content areas of Algebra, Biology, and Literature. These exams help determine whether or not a student has mastered the standards associated with earning a high school diploma. The results below are based on estimates of the best scores to date generated by students who were in Grade 11 during the 2022-2023 school year.

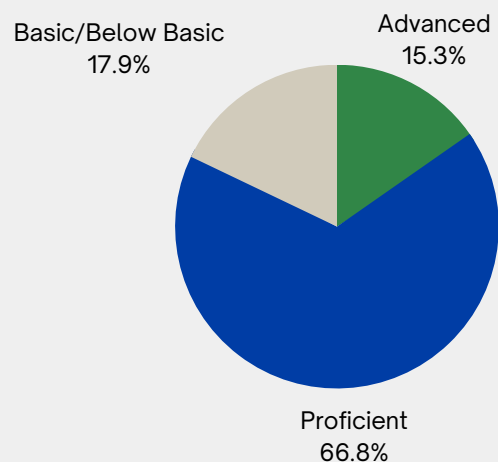
Algebra I

Literature

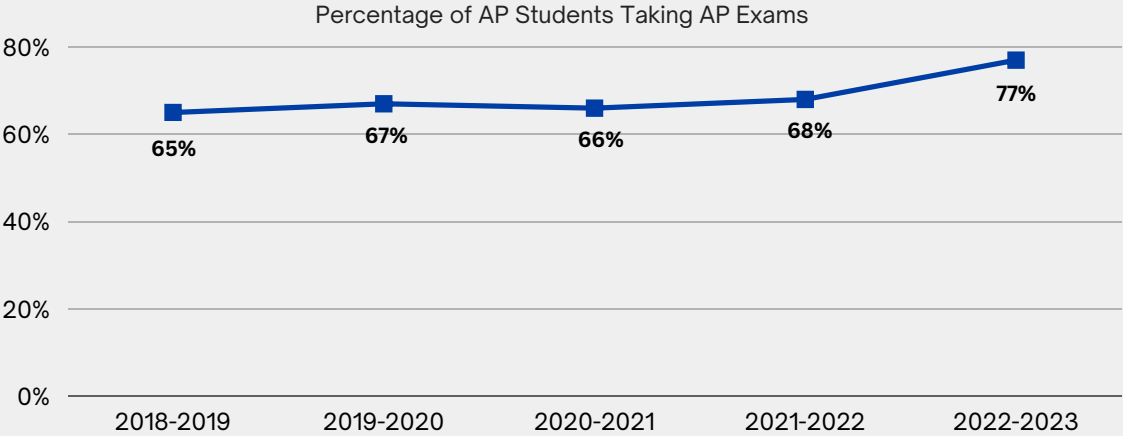




AP Exams

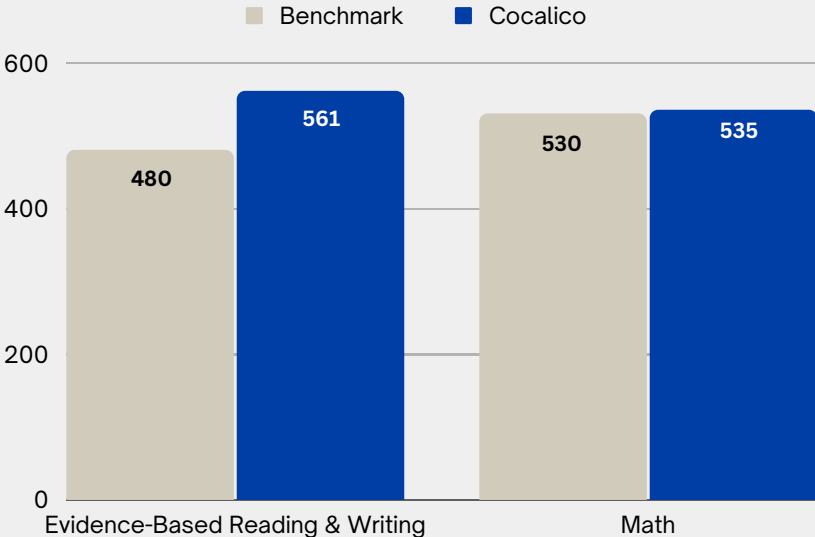
Students at Cocalico have the opportunity to demonstrate advanced achievement by taking college-level AP courses during their high school years. In the 2022-2023 school year, the percentage of students enrolled in AP courses who took an AP exam increased by 9%. Sixty percent (60%) of test takers scored a 3 or higher (on a 5-point scale) on at least one exam, thus showing proficient or advanced performance on college-level assessments.

In the 2022-2023 school year, the following AP courses were offered: Language & Composition, Literature & Composition, Calculus AB, Calculus BC, Statistics, Computer Science A, Biology, Physics II, U.S. Government & Politics, Spanish Language & Culture, and Microeconomics.



SAT Exams

Another indicator of a student's academic performance includes the scores achieved on the Scholastic Aptitude Test (SAT). The most recent scores of 2023 high school graduates who took these tests while in high school are reflected in the chart below.

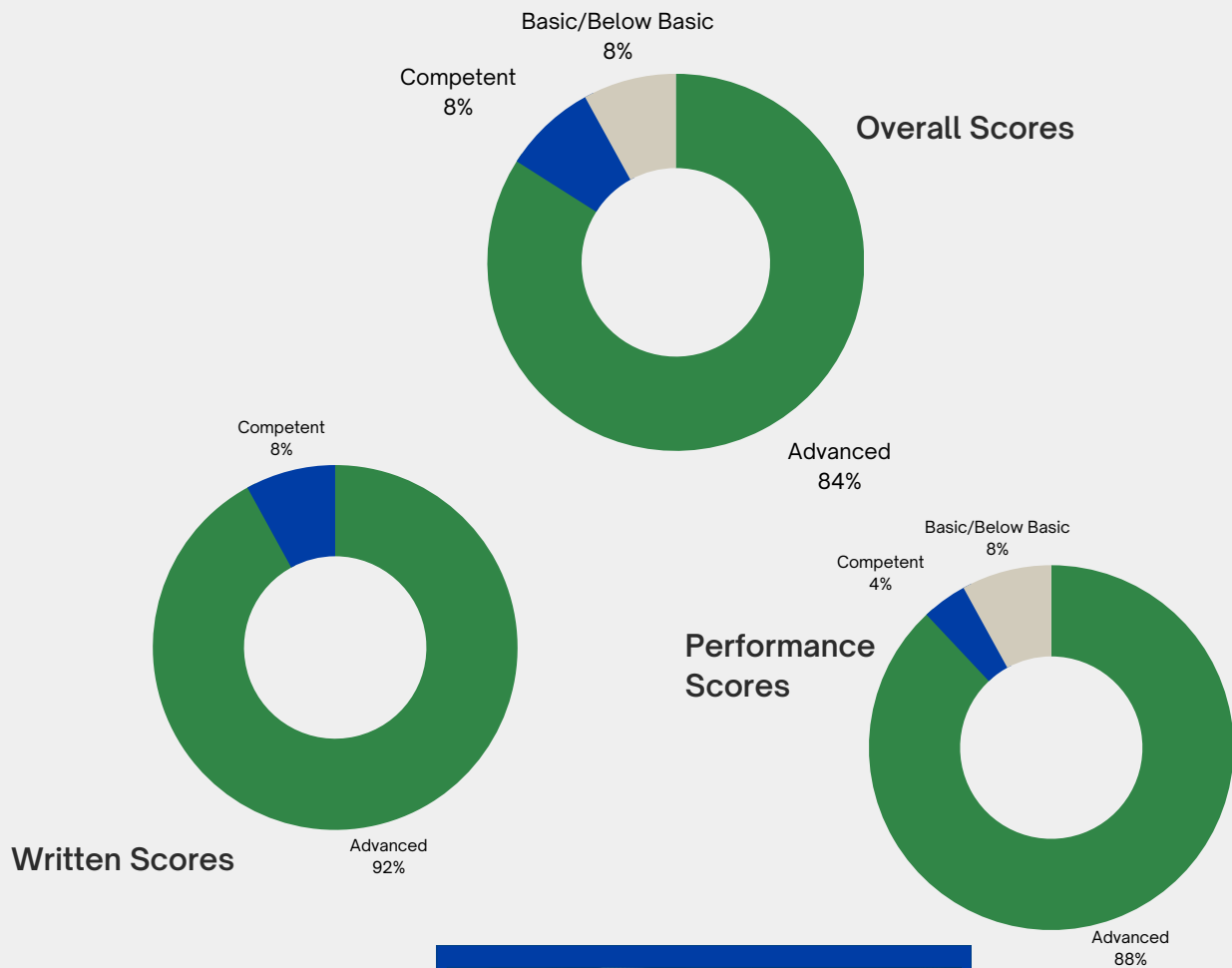


80 students took the SAT in 2022-2023 (32% of 2023 graduates). This number has decreased over the past few years, possibly due to the relaxation of SAT scores as prerequisites for college admission.

NOCTI Exams



Standardized National Occupational Competency Testing Institute (NOCTI) exams are given to students participating in courses at the Lancaster County Career & Technology Center (CTC). These tests are designed to measure job readiness skills and consist of both a written and performance component. Cocalico students performed extremely well on NOCTI exams during the 2022-2023 school year. Twenty-five (25) students participated in the testing, and 92% of those students scored competent or advanced in both the written and performance components.



Future Ready PA Index



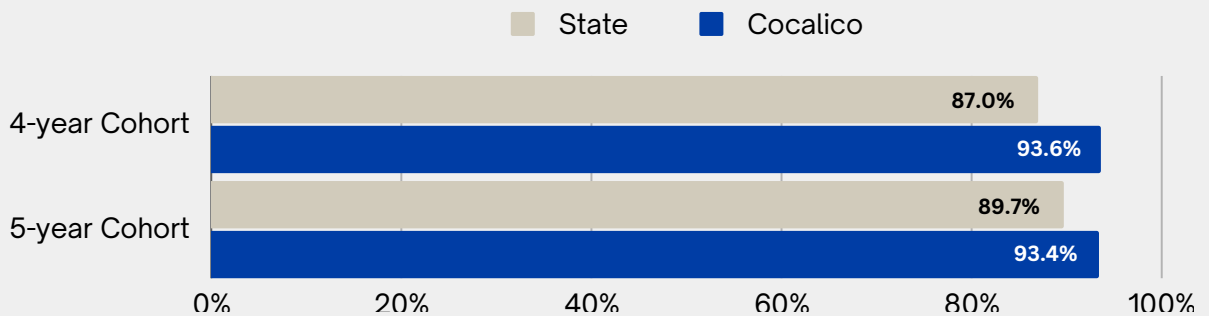
The Future Ready PA Index is a collection of progress measures that are related to school and student success. The Index includes a range of assessment, on-track, and readiness indicators, to more accurately report student learning, growth, and success in the classroom and beyond.

Career Ready Benchmarks

In 2015, Pennsylvania regulation, Chapter 339, established the development and implementation of a comprehensive K-12 curriculum focused on career awareness and guidance. In addition, all school districts were required to incorporate the Career Education and Work (CEW) standards into classroom lessons.

Career evidence is collected at all grade levels throughout each school year and is reported annually to the state for Grades 5, 8, and 11. The Career Standard Indicator, presented in the chart below, identifies the percentage of students demonstrating meaningful engagement in career exploration and preparation aligned to the CEW standards.

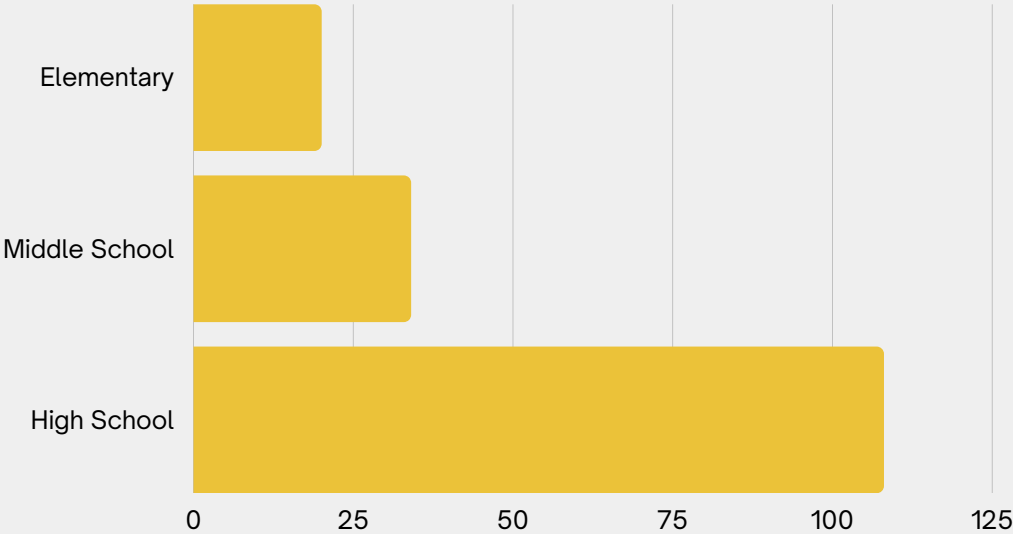


Safe Schools Report

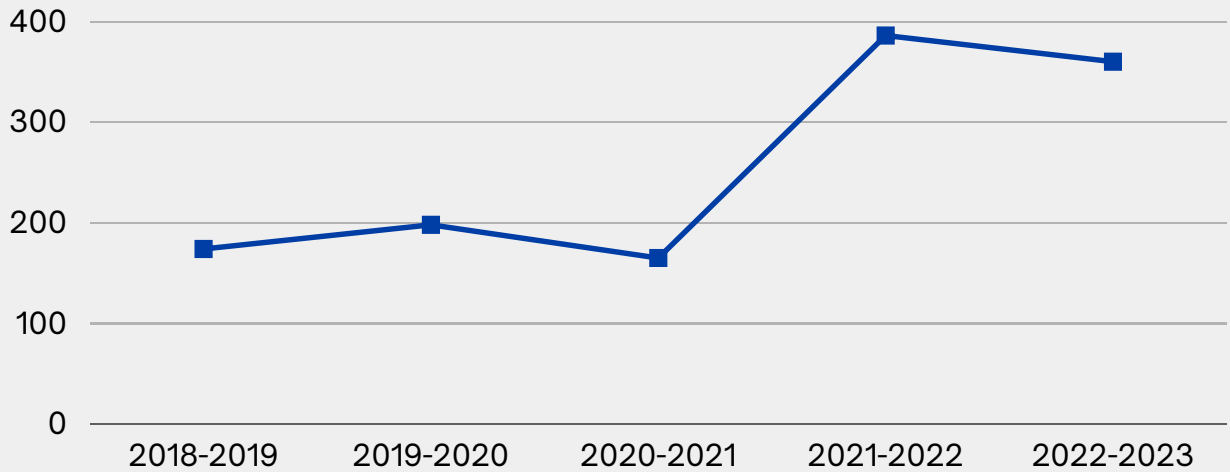

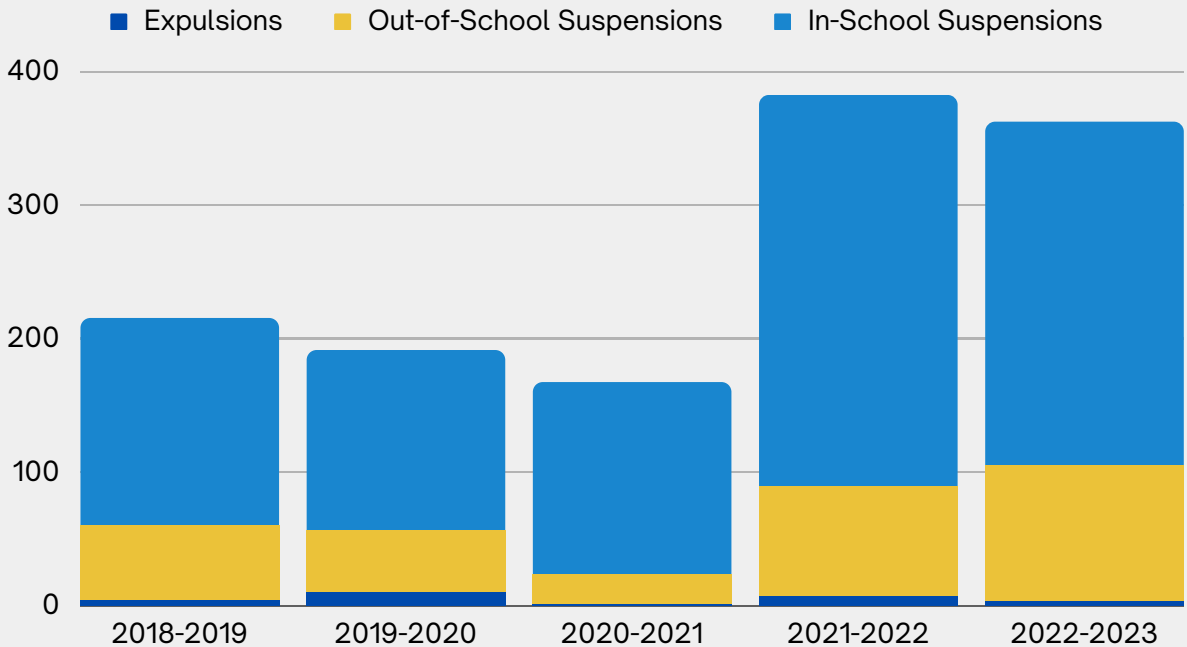

Types of Reportable Incidences

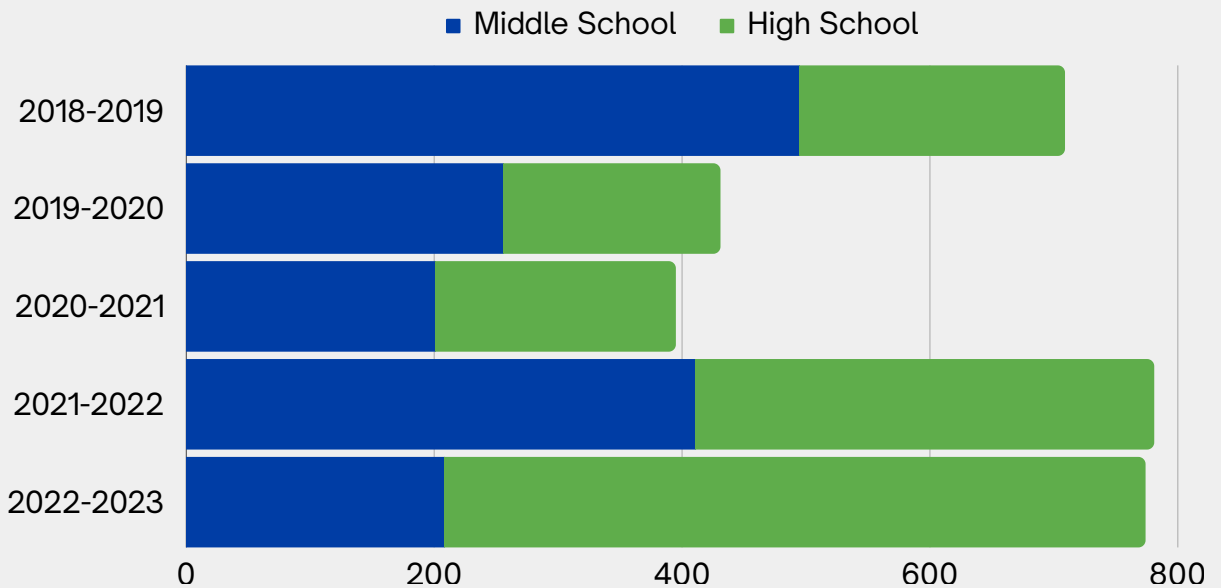

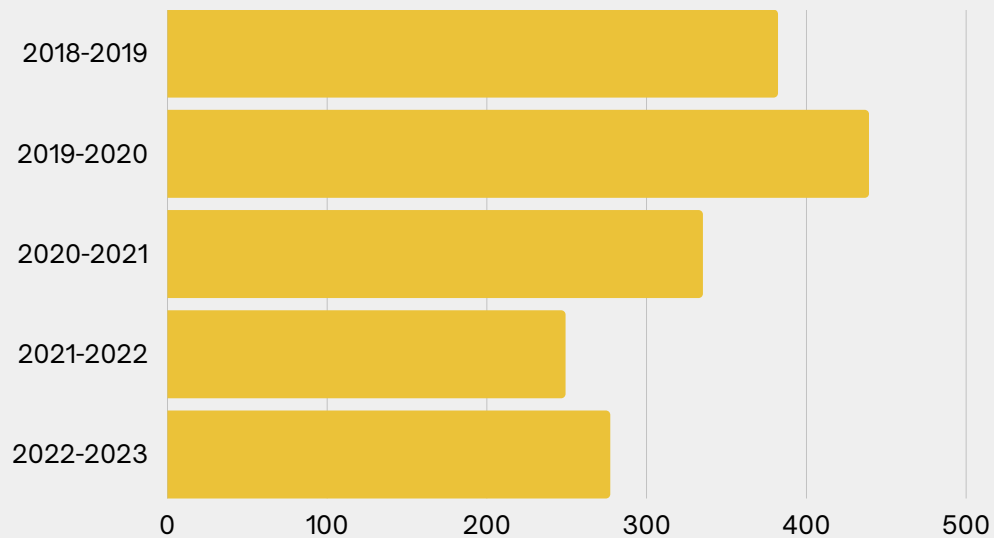

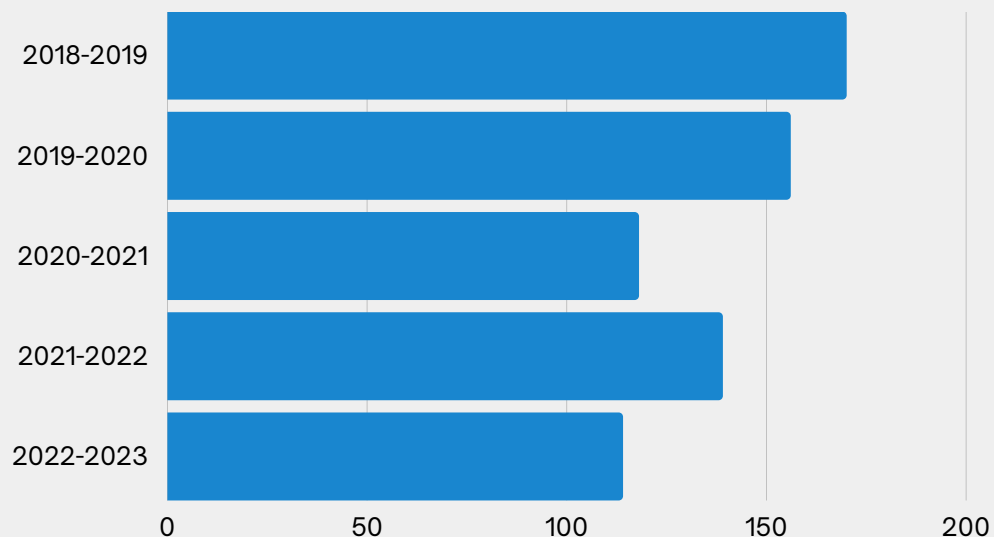
Mental Health Supports

of SAP Group Participants

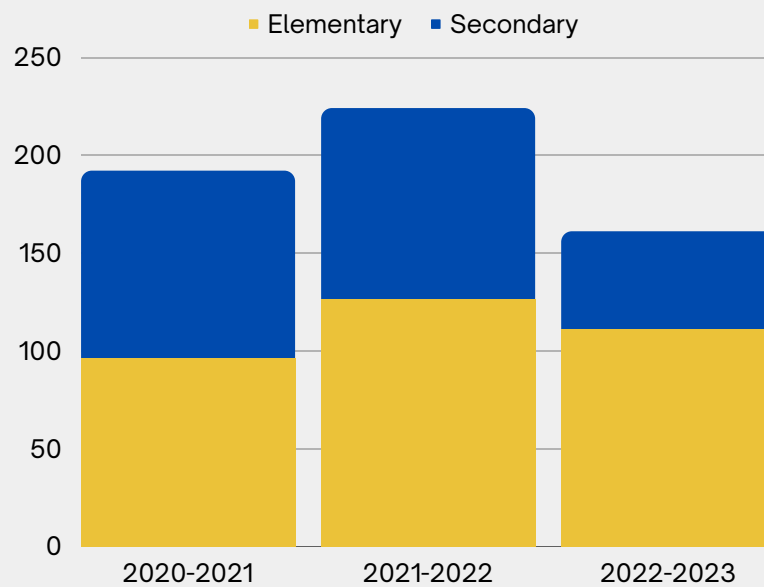


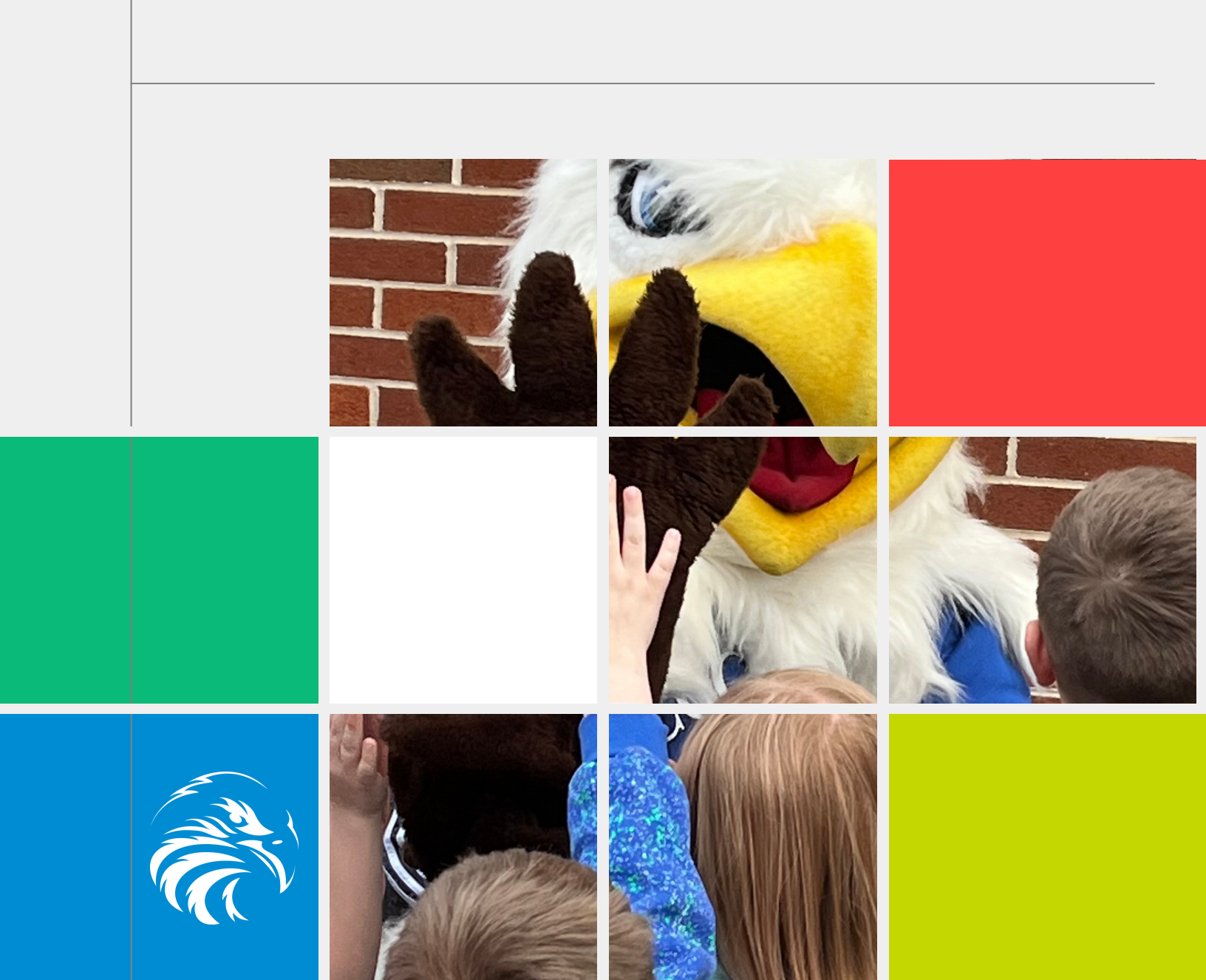


Mental Health Supports

Cocalico School District partners with Community Services Group (CSG) to provide outpatient mental health counseling to students whose needs extend beyond the services provided by school counseling. CSG employs a licensed therapist to provide this service at each school building, and counseling sessions are funded by individual students' insurance companies.
